

# **NEU-PC Plus Application**



### **Information & Instructions for Applicant**

The NEU-PC Plus Programme by IMDA provides opportunity for students of low income families to own a computing device at a subsidise price. Since the inception on 1:1 Computing Programme in Year 2015, successful applicants have purchased a tablet device with free apps and 3 years of free broadband subscription at a subsidised price.

#### **NEU-PC PLUS Scheme**

- <sup>-</sup> The application is open to Singapore Citizens or Permanent Residents.
- The Applicant must be a full time student in Admiralty Secondary.
- Past recipient of a PC bundle under the NEU PC Plus Programme who received a tablet device, may reapply only after a lapse of three (3) years from last deployment to the household.

#### A tablet device includes:

- iPad 32GB WiFi minimum or equivalent
- Productivity Tools and apps
- Mobile Device Management Software
- -1 year warranty

#### **Eligibility Criteria**

- The Applicant's combined gross monthly household income must not exceed \$3,400 OR the per capita income\* of the Applicant's household must not exceed \$900. If there is a permanently disabled household member, per capita income must not exceed \$1,125.
- Each eligible household can only apply for one (1) device regardless of the total number of school-going children.

#### **Submission**

Please submit your application to General Office by <b>04 Jan 2019</b> with the following documents:	
- Complete application form (including the main application form, the Deed of Undertaking and Indemnity form)	
- Photocopy of both sides of Applicant and all household members' NRICs (for children below 15 years	
old, Birth Certificates are acceptable)	
- For all working adults in the household (including self-employed), the latest Income Tax Assessment	
or payslip or employment letter or a 3-month CPF contribution history (where applicable)	
- For working adults who do not have fixed monthly salary, the last 3 months payslip or a 3-month	
CPF Contribution History (where applicable)	
- Latest broadband bill from service provider (Singtel, Starhub, M1, MyRepublic, ViewQwest or others)

- We agree to keep the PC-Bundle (device and the broadband access) at home for 3 years from the date of deployment. We also understand that the device model and/or Broadband Service Plan available may vary from time to time, and that school has the right to change the selected device model, software, apps and/or Broadband Service Plan to a comparable alternative. School shall have the sole discretion to decide on what is a comparable alternative.
- We agree to fully cooperate if a random check to verify our PC-Bundle status is conducted at our house or the place our existing PC-Bundle resides. We will allow the inspector to check and test our PC-Bundle.
- We agree to inform IMDA or the school of any change in my address or contact information within 30 days from the date of change.
- We acknowledge that, for the purpose of facilitating my application by IMDA, any and all government agencies
  or statutory boards that have any of my records may share the information with IMDA, if it is relevant to IMDA's
  work with me and/or my household.
- We also acknowledge that the information which we and/or members of our household provide may be shared with any government agency, statutory board or person authorised by IMDA, for the purposes of rendering or assessing eligibility for financial or other assistance; for research in which our household members, as a specific individual, shall not be identified; or for any other purposes prescribed or permitted under Singapore Law.

- The Applicant and/or the Applicant's parent/guardian shall make co-payment for the device. The amount is dependent on the current model that the school choose and the latest price of the device.
